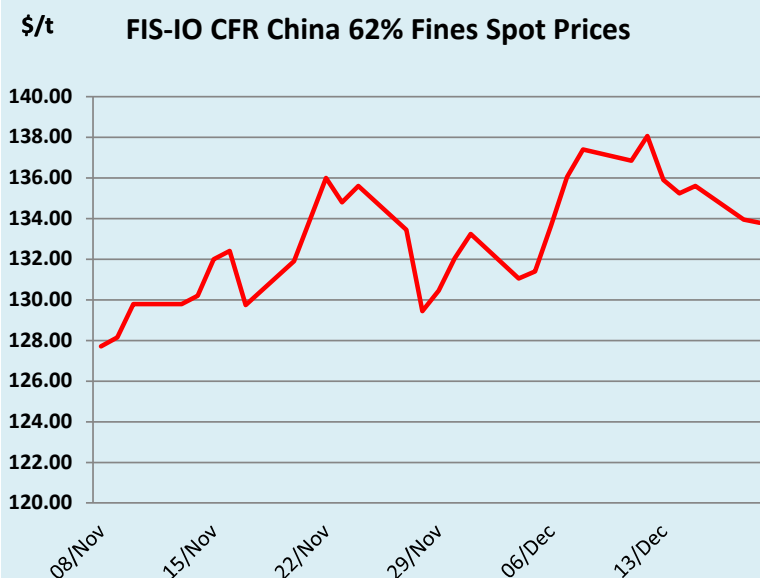

Market Commentary / Recent Trades

Iron ore opened this morning at \$131.85, dipping to lows of \$131.65 early in the session then quickly rebounding to highs of \$132.80. The afternoon session opened at \$131.95, edging to highs of \$132.35, closing at \$132.05. On the spreads, we saw Jan/Q2 trading in the market in a total of 225kt, with the spread tightening from \$6.50 to \$6.45. Additionally, we traded a 100kt of Mar/May at \$3.40 in the afternoon with interest observed in Feb/Mar. The market also traded Jan/Feb in a total 250kt and Jan/Mar in 100kt.

China's 45 major iron ore port arrivals are up 1.297 million tonnes on the week while Australia and Brazil delivered 19 million tons of iron ore, down 1.1 million tons on the week.

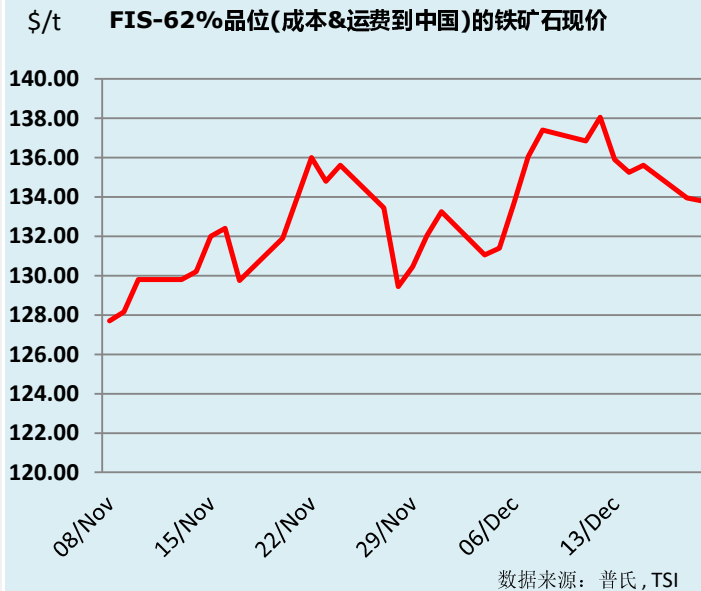

市场评论 / 近期交易

铁矿石开盘交易于131.85美元，盘中一度跌至131.65美元的低点，随后迅速反弹至132.80美元的高点。下午开盘交易于131.95美元，随后小幅升至132.35美元的高位，收于132.05美元。价差方面，1月/Q2交易量达22.5万吨，价差从6.50美元收窄至6.45美元。此外，下午3月/5月在3.40美元交易10万吨，2月/3月在3.40美元有不错的市场兴趣。1月/2月交易25万吨，1月/3月交易10万吨。

中国45个主要铁矿石港口本周出货增加129.7万吨，而澳大利亚和巴西出货1,900万吨，本周减少110万吨。
