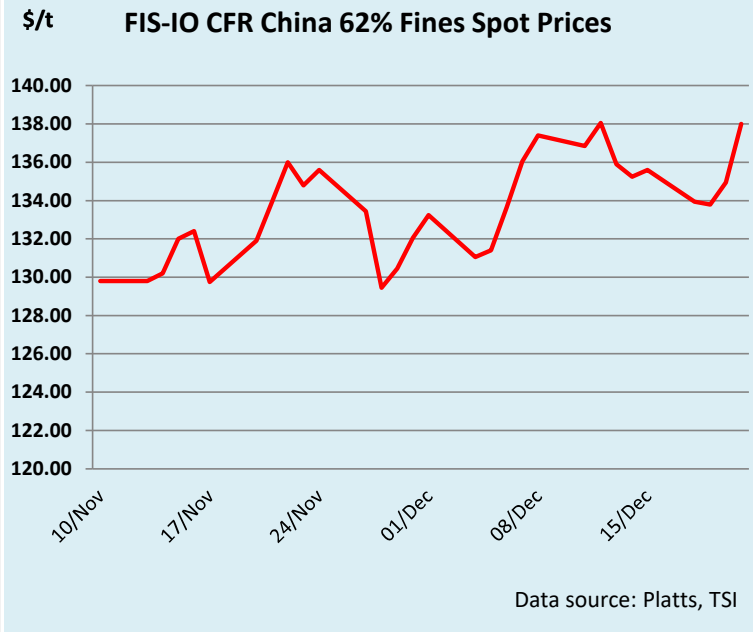

## Market Commentary / Recent Trades

On Thursday morning, the market opened at \$134.75, making gains throughout the day and reaching highs of \$137.75 late in the afternoon, driven by anticipated positive Chinese stimulus packages. While no concrete measures have been announced yet today, decent volumes have been traded, with Jan/Feb trading at \$1.45 for nearly 0.25 million tonnes.

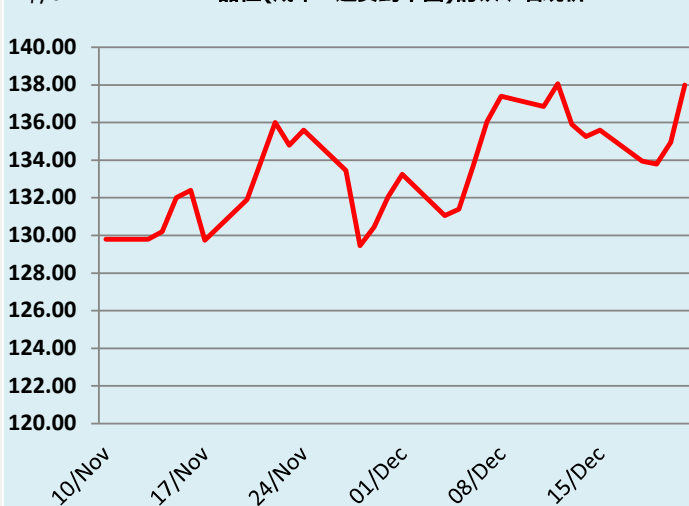
