


## **Oil and Energy Market News**

Brent crude futures are lower this morning, having settled on Friday at \$78.76/bbl in the front month. Demand concerns appear to be a key driver of today's weakness, following weekend news that Saudi Arabia cut its selling prices to all regions, including Asia. The drop for Asia was more than expected at \$2 per barrel. These movements have overshadowed further concerns around Red Sea tensions and the risks of wider conflict in the Middle East.

## Fuel Oil Market News

The fuel market is choppy this morning, with front Sing 0.5% crack off 50 cents already, trading last at \$10.10/bbl. Euro cracks are also softer, down 25 cents in the front HSFO crack at -\$11.60/bbl.

Sing spreads across HSFO and VLSFO have been going offered in early trading, with 0.5% spreads losing more in Q3 and Q4 contracts – off as much as a dollar.


