



Mar24 Brent crude futures are trading higher on the day here, after another missile attack by Houthi rebels on a cargo ship in the Red Sea. Prices are also finding some support from falling output in North Dakota, which is down 600K barrels per day. A stronger US dollar, as well as wider global economic concerns are acting as an offset to the bullish factors. The contract touched an intraday high of \$79.40/bbl, so far.


