


Oil and Energy Market News

Brent has tracked fairly sideways in the first part of today's trade, with the more actively traded Apr24 futures contract having settled around \$81.83/bbl. Market participants continue to assess the Middle East conflict escalation risks and increasing attacks on Russian energy infrastructure against demand concerns amid a weak property sector in China.

The market looks ahead, this week, to OPEC+ ahead of the JMMC meeting on Thursday as the group appears to be making a slow start to its new output cuts.
