



The London afternoon saw the front month contract trade to a high of the day at \$142.10 before dropping to close at \$141.30. The session was dominated by outright Mar interest with it trading in a lot of size above \$139.80. Jan/Feb traded in some size as well as Feb/May at \$5.1. There was a lot of Mar/May interest in the market, but it failed to trade in considerable volume.
