



The London afternoon iron ore session saw a drop off in iron ore closing at \$135.40. The Jan/Feb spread traded in considerable size as the front month contract fell more than two dollars from close yesterday. Montly outrights garnered minimal attention but there was some Q1 outright interest. However more importantly the latter quarter spreads narrowed with Q3/Q4 trading at \$4.45 in size and then \$4.4.
