


## 17 January 2024

Iron ore in London afternoon saw a reasonably volatile session on the front month, trading to a low on the day of \$125.10, before rising to \$126.35 and then closing at \$125.80. Just before the DCE open we saw Cal25/26 trading \$9.4 in decent size as the spreads far out the curve narrowed. On the monthly spreads, Feb/Apr was the one that gathered the most attention trading \$3.05 in size. Elsewhere there continued to be some quarters trading in particular Q2.
