


## 22 January 2024

Iron ore in the London afternoon was reasonably subdued with the price range bound around \$129, until prior to close where we reached highs of the day at \$131.15. We saw continued Q2 outright interest along with Feb/Mar spreads trading at \$1.6 and \$1.65 in size. All other spreads were relatively quiet besides some Feb/Apr trading \$3.2 in 35kt. In general the market was rather quiet with little news jogging traders.
