



Iron ore in the London afternoon began by dropping off from around the days high to \$135.80. However some of this drop was regained closing at \$136.30, 10 cents lower than close on Friday. Outrights saw minimal activity besides some continued Sep and Q2 trading. On the spreads we saw Feb/Mar trading \$1.25 in a bit of size, as the spread narrowed slightly, as well as Jan/Mar trading flat.
