## Market Commentary / Recent Trades

Iron ore Feb opened this morning at a low of \$141.60 and rallied to peak twice at at \$143.40. The morning session closed at \$142.50. In the afternoon, Feb opened at \$142.65 and hit lows of \$141.95 before closing at the high of \$142.70. Lots of Mar/May interest in decent size, tightening from \$3.45 to \$3.40 though the day. Jan/Mar traded in the afternoon as well, tightening from \$2.75 to \$2.60. We see extended iron ore gains today as further support from Beijing is expected, with the PBOC pledging to offer low-cost financing to some of the country's largest lenders.
