Market Commentary / Recent Trades

Iron ore opened this morning at \$135.25 and remained fairly range-bound through the session, hitting highs of \$135.90 and lows of \$134.40 before closing at \$134.70. In the afternoon, iron ore opened at \$134.75, hitting highs of \$135.25 before plummeting to lows of \$133.05 and closing at \$133.45.

Large volumes traded in the market today, with Cal25/26 trading in size at \$10.10 through the day. In the morning, we saw Feb/Apr's spreads tighten from \$2.80 to \$2.75 in decent sizes. Jan/Apr widened from \$5.30 to \$5.60 through the afternoon. Apr/Jun also widened, from spreads of \$3.20 to \$3.25. Notably, Feb/Sept also traded in \$11.15 in size.

Iron ore futures have lost steam for a fifth consecutive session, with the Singapore benchmark at its lowest level in nearly three weeks. Negative signs that steel products are piling up and a lack of fresh stimulus could be weighing on the market.

市场评论 / 近期交易

铁矿石今日早盘开盘于135.25美元,盘中区间波动,最高至135.90美元,最低至134.40美元,收于134.70美元。午后,铁矿石开盘于134.75美元,最高至135.25美元,随后暴跌至133.05美元的低点,收于133.45美元。

今天市场交易量可观,Cal25/26交易于10.10美元。早盘2月/4月价差从2.80美元大幅收窄至2.75美元。1月/4月午后从5.30美元扩大至5.60美元。4月/6月价差也从3.20美元扩大至3.25美元。尤其是2月/9月在11.15美元有不错交易量。

铁矿石期货已连续第五个交易日失去动力,新加坡基准价格跌至近三周来的最低水平。钢铁产品库存增加以及缺乏新的刺激措施可能会给市场带来压力。
