Market Commentary / Recent Trades

Iron ore opened this morning at \$132.45, remaining fairly rangebound throughout the session. In the morning, we hit highs of \$133.25 and lows of \$131.65. In the afternoon, iron ore opened at the highs of \$132.70 and declined steadily through the session to close at lows of \$130.35.

The market quarterly trades in volume today, with Mar/Q2 trading at \$3.20. We saw a lot of interest in Q2 outrights as well, trading between \$128.00 and \$128.30 through the day. Feb/Sept also traded in size today at \$11.40.

Iron ore slipped to the lowest level since December 6th today. China's consumer prices extended decline for a third month in December, while factory-gate prices also fell, official data showed, highlighting persistent deflationary pressures in an economy struggling to mount a solid recovery. Faltering demand due to thin margins among Chinese steelmakers also undermined iron ore prices this week.
