Market Commentary / Recent Trades

Iron ore opened to a rocky start this morning at \$129.85, fluctuating to highs of \$131.40 and lows of \$129.60 before closing at \$131.00. In the afternoon, iron ore opened at \$130, hitting highs of \$130.60 early in the session before a plunge into lows of \$127.85 and closing at \$127.95.

This morning, we saw Jan/Feb selling interest, with spreads fluctuating between \$4.00 and \$4.80. Jan/Mar also traded in size, tightening from \$7.00 to \$6.75 through the day. Notably, a Jun/H2 and Feb/Q2 traded in the market at \$5.50 and \$4.60 respectively. Other quarterly spreads like Q1/Q2, Q2/Q3 and Q3/Q4 also traded today.

The substantial decline in price observed today may be attributed to the market's response to the People's Bank of China's (PBOC) failure to meet expectations for rate cuts over the weekend.
