



Oil and Energy Market News

Crude markets are fairly steady this morning, with front month Apr24 Brent futures trading around settlement of \$80.55/bbl. Support is coming from new property stabilisation measures in China, which is considered a key driver of global oil demand growth. Yesterday, Brent fell by \$2, driven by weak manufacturing activity out of China, a surprise US weekly crude inventory build and a stronger US dollar after the US Fed kept rates on hold. Market focus today is likely to turn to OPEC+ and any indications of future production policy in reaction to the JMMC meeting later on.


