



Iron ore continued its fall this afternoon in London as the low of the day was reached at \$123.75, and then finding a bit of support and closing at \$124.25. The outright contracts besides Q2 had little interest in the session. Notably we saw Mar/Jun trade \$4.5 in size before the spread narrowed in the session. We also saw Mar/Q2 trading in a lot of size as the spread narrowed to \$2.9. The theme of narrowing spreads continued with Mar/Apr trading \$1.4 in size.
