The expansion of the Trans Mountain oil pipeline will cost about C\$3.1 billion (\$2.3 billion) more than projected in May. The US has struck 230 targets in Yemen following Houthi-led attacks against shipping in the Red Sea. US gasoline margins hit the highest since August on unplanned refinery outages and a heavy maintenance season. Vietnam's Dung Quat refinery plans maintenance for 48 days starting March 15, according to a post. Parkland Corp.'s BC refinery near Vancouver has completed repairs and will resume normal operations in early March. Pemex swung to a profit in the fourth quarter as government support relieved pressure on the state-owned company.
