## 12 March 2024

Iron ore through the day gained strength, but upon the London afternoon session this was curtailed, dropping two dollars to close at \$107.35. The decline was relatively continuous as spreads narrowed further. The Apr/Jun spread began the session trading at \$1.9 before later on trading at \$1.85 in size. Along with this Q3/Q4 traded \$2.85 with spreads continuing to narrow. Q1-25/Cal-25 again traded this afternoon after trading at \$4.10 yesterday. It first traded \$3.95 and then narrowed further to \$3.75 and then \$3.65. In tandem Cal25/26 traded \$7.8 after trading \$8 earlier in the day. Notably also Q2-25/Q4-25 traded \$4.9 in some size. Outside of spreads, Q2 outrights traded in a decent amount of size along with Mar at \$111.6.
