The London afternoon session in iron ore was bipolar. Originally the front month shrugged off the supposed \$100 psychological logical trading to a daily low of \$97.10, a big change from \$111.60 seen at the beginning of the week. However the last 20 minutes of the session saw a rapid turnaround closing at \$99.20 and rising further post close. Once again we saw spreads tighten further at the end of a hectic week. The session early on saw Q3/Q4 trade \$1.85. However later on in the session we saw Q2/Q4 trading \$3 but in small volume. The most notable trade was Q4-24/Q2-25 trading \$3.9 in 20kt.
