The London afternoon session saw Iron ore trade between \$105.50 and \$106.80 closing at \$105.80. The session began with spreads widening as Apr/Jun traded \$1.75 in several clips. Despite this there was limited other action on spreads as most of the session was dominated on outrights. We saw 2H and Cal 25 selling interest in the market trading in multiple clips as the front month came down to jostle below \$106. In a rather uneventful afternoon session we did also see Apr trade in some big clips as well as Q2 interest trading between \$104.75 and \$105.
