

Iron ore had a subdued afternoon session closing at \$108.95, a tad lower from where it opened but over a dollar down from the highs of the day at \$110. Jul/Sep traded \$1.55 showcasing the expansion we have seen in spreads since the beginning of the day. Likewise Q3/Q1 traded \$4.5 in 20kt. Elsewhere there was little to report from a quiet London afternoon session.
