
### Oil and Energy Market News


Brent crude futures have been very choppy this afternoon, as the market weighs upon conflicting comments from senior Israeli officials and Hamas sources on progress in negotiations for a ceasefire in Gaza. The front Jun24 contract has retreated, here, from an intraday high of \$91.10/bbl, after some aggressive 40 cent swings.

Market participants also had their eyes on comments from Citadel that oil supply would be extremely tight in the second half of the year.


