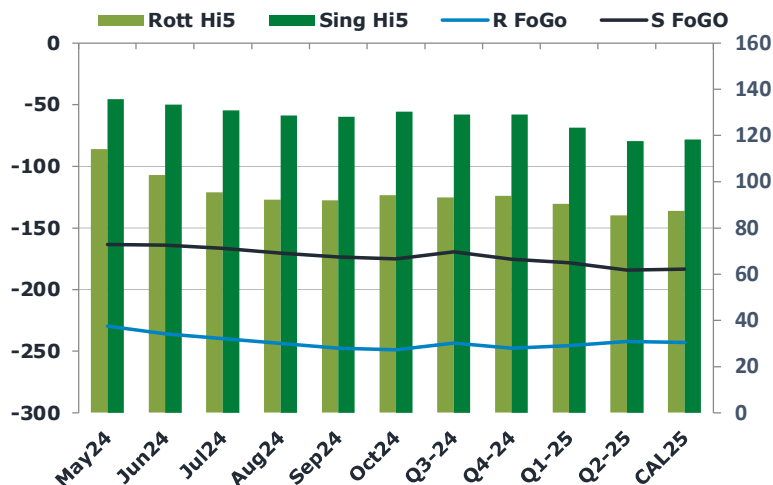
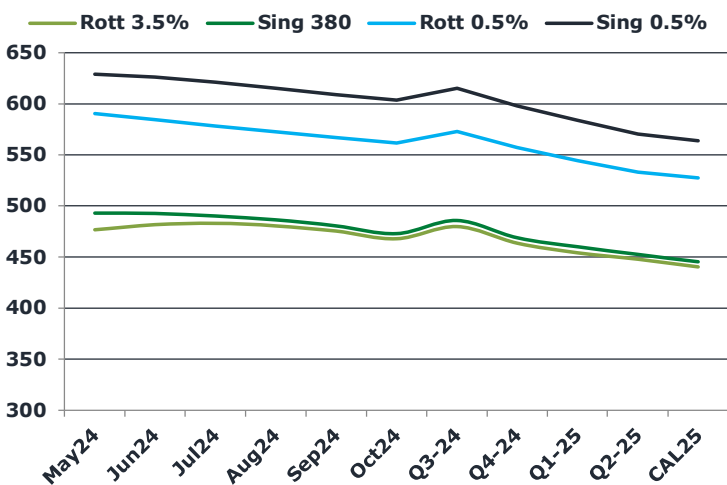
Despite the weekend's drone strike on Israel from Iran, crude markets have had a fairly muted response. World powers rushed to diffuse the situation and the risk premium seems to be already priced in. Front Brent futures off 0.90% here.

Jun24 Brent spiked to a high of \$92.18/bbl on Friday amid speculation of the response from Iran to the Israeli bombing of its consulate in Damascus.

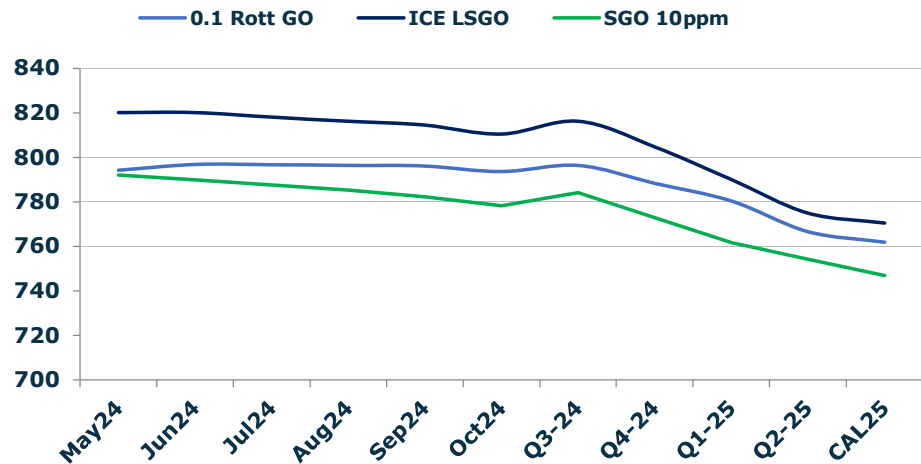
