



Crude futures and time spreads continue to pull back today, touching intraday lows of \$86.09/bbl before rebounding earlier in the day. A reducing Middle East risk premium as Israel is still yet to retaliate to Iran's attack last weekend, thus reducing the concern over interruptions to Iranian oil supply, adding downward pressure to prices.

The fuel market was extremely turbulent today, particularly with aggressive swings in the prompt VLSFO cracks. May24 Sing 0.5% crack traded across a \$1.50 range today, touching highs of \$12.60/bbl before pulling back to \$11.89/bbl – 51 cents higher on the day.

May24 Rotterdam 3.5% barges crack trades last at -\$10.65/bbl – 80 cents higher than yesterday's settlements.


