
Oil and Energy Market News


Oil prices fell over a percent yesterday, with the more active Jul24 Brent future settling at \$87.20/bbl, on prospects of a ceasefire deal for Gaza and today those losses have been held.

Crude has drifted lower during today's APAC session as markets look ahead to the FOMC decision tomorrow and news on a Gaza ceasefire agreement. Market participants monitor The Fed closely as any further indication that the first rate cut will be delayed further is likely to weigh on oil prices.


