

The London afternoon saw iron ore front month relatively unchanged for the first half of the session before dropping precipitously in the second. We reached a low of \$107.35 before closing at \$107.60. Spreads in the session widened slightly with Jun/Aug trading \$0.90 in a bit of size. Elsewhere the May/Jul spread traded in the greatest volume at \$0.90. We saw a bit of quarter spread action as Q3/Q1 traded \$3.35. Outright activity was minimal with nothing of size or further out trading.
