Another tepid session in iron ore with the flat price closing at \$116.05. After initially dropping to \$115.50 soon after open, the majority of the session we were rangebound between \$116 and \$116.80. The spreads saw some keen selling interest. May/Q3 traded \$2.45 in 60/20kt whilst Jun/Sep traded \$2.5 in 100kt. Also Jun/Aug traded \$1.65 and May/Jun traded \$0.8.

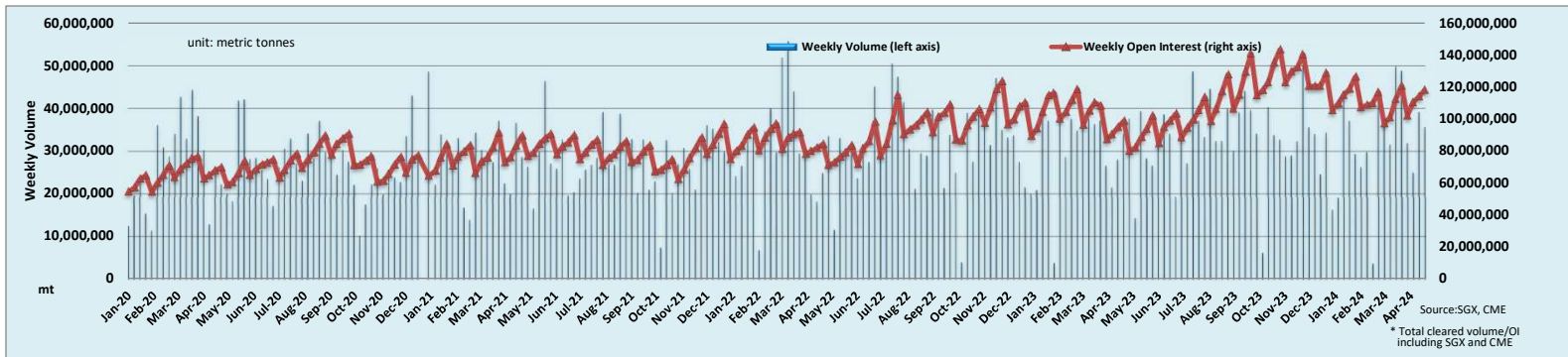
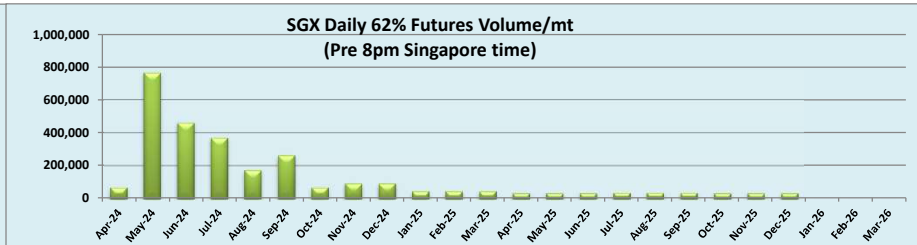
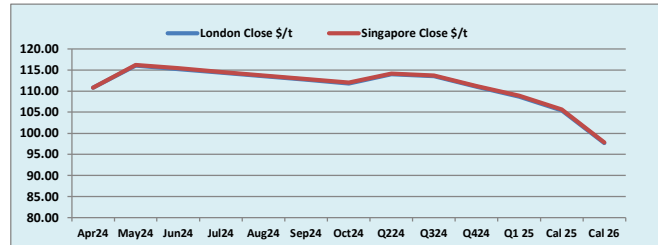
