
The expansion of the Trans Mountain oil pipeline is almost complete and the project is on track to start up on May 1. Seaborne oil flows took a tumble in March as sharp declines from Mexico, the US, Iraq and Qatar more than offset increases elsewhere. The US said it would consider revoking its recent designation of Yemen's Houthis as terrorists if the Iran-backed militants cease shipping attacks. Iraq again missed its OPEC+ oil production target in March, potentially setting itself up for added scrutiny. Commodity trading house Gunvor Group Ltd booked its second-biggest profit ever, but flagged market volatility has cooled.


