
Mexico's state-controlled oil company said a fire at one of its Akal-B oil platforms in the Campeche Bank left nine people injured and one person dead Saturday afternoon. Norway's employers and the largest private-sector trade union clinched an agreement on wages with the help of the state mediator, averting a wide-ranging strike. Russian President Vladimir Putin sent his emergency minister to the Orenburg-region city of Orsk, where an oil refinery halted operations and thousands of people were evacuated due to major flooding. 


