



In this afternoon's trading, front end VLSFO cracks softened, off about 25 cents each as we approach European market close, to trade last at \$11.35/bbl and \$4.00/bbl in the Sing and Euro, respectively.

Jun24 HSFO EW is flat on the day at \$19.25/mt, but the Rotterdam 3.5% crack is weaker by 35 cents from settlement, trading at -\$9.55/bbl. HSFO spreads for Sing and Euro are weaker.


