
Oil and Energy Market News


After strengthening yesterday, Brent crude futures are trading near the top end of a \$3.5/bbl range. Data out of China today reinforced the uneven nature of the current economic backdrop, with consumer spending softer relative to industrial activity.

WTI has been rising faster than Brent due to supportive US macro data and a potential soft landing scenario for the US economy with US rate cuts this year.

Jun24 Sing 0.5% crack is off 50 cents at \$10.25/bbl and the Jun24/Jul24 spread is down a dollar, trading last at 6.00/mt. The Rotterdam 0.5% crack is yet to trade but has gone offered in the market at 3.50/bbl - 30 cents lower than settlement.

Sing 380cst spreads are a tick lower in the front end.
