


The London afternoon saw some further weakening in the Iron ore price. Upon open of the T+1 we saw a rise to \$120.80, but this was short lived as we dropped to close at \$119.30. Just prior to open Jun/Jul traded at \$0.10 in reasonable size across multiple clips, a big shift from opening up at \$0.40 in Sing morning. This narrowing of spreads seen throughout the day was demonstrated with Jul/Sep trading \$0.90 and then \$0.80 in 200kt. The notable trade of the London afternoon however was Aug/Q4 trading \$2.00 in a total of 330/110ktm. There were minimal notable outrights but we did see a perpetual interest in Jul trading in many clips.
