

## **London Iron Ore Market Report**

## 28 May 2024

London's afternoon session began with a slight dip from the previous session's close of \$117.85 to open at \$117.80, we then saw a slight push into the session highs of \$118.20, however price then retreated to \$117.25 which marked the session low. By the close of the session the price had risen slightly to \$117.55. Spreads were more or less unchanged throughout the session with Jun/July still trading at par, Jun/Aug moved slightly from the previous session to \$0.35. Notable trades included Jun/July continuing to trade in clips totaling 300kt at par, this brings an overall size of over 550kt for the day. There was also sustained interest in Jun/Aug with 25kt trading in the session, adding to the 400kt+ in the previous sessions.
