The London afternoon session opened at \$115.75 and quickly saw a slight dip to \$115.50 before printing the highs of the session at \$115.90, the rest of the session was relatively quiet with price ranging between the session low of \$115 and \$115.75 before eventually closing at \$117.30. Prior to the session open, Q3/Q4 traded at \$1.90 in 30kt, highlighting ongoing interest from the Singapore morning and afternoon session. Sep/Q4 also traded pre-open in good size of 240kt x 80kt at \$1.45. Jul/Aug spreads were basically unchanged but a touch weaker, we saw a decent clip trade \$0.35 in 50kt. There was decent outright interest in June, trading \$115.64 in 71.1kt. Once the session was nearing its close Jun/July traded \$0.05 in 40kt total, then finally post close Jun/Jul traded at par in 100kt.
