Iranian President Ebrahim Raisi has been killed in a helicopter crash in a mountainous area of the country. Drone strikes forced a small refinery in southern Russia to halt operations on Sunday while Moscow's troops kept up "intense" fighting in northeast Ukraine after recent advances, as well as along the eastern front. A China-bound oil tanker in the Red Sea was struck and temporarily disabled by a ballistic anti-ship missile fired by Houthi militants, the US Central Command said. No progress has been made in long-standing talks for international oil companies to resume exporting crude from the Kurdistan region of Iraq, Prime Minister Mohammed Shia Al-Sudani said. China imported 194,000 tons of crude from Venezuela in April, the third straight month of purchases from the OPEC producer, according to customs figures released Monday. Gasoline exports from China collapsed to the lowest level since 2015 last month as refiners waited for new batch of shipment quota that'll allow them to renew flows to overseas markets, while maintenance programs slowed local processing and holidays boosted travel demand.




