Market Commentary / Recent Trades

With the DCE shut today for the first day of Chinese Labour Day holidays, we saw a high of \$115.55 and lows of \$114.35 hit earlier in the morning.

Liquidity was thin in the light of the Singapore and Chinese public holiday. May spreads narrowed today, with May/Jun trading at \$0.45 around 2pm, before narrowing 5 cents to trade at \$0.40 in large volume of over 300kt in the late afternoon.
