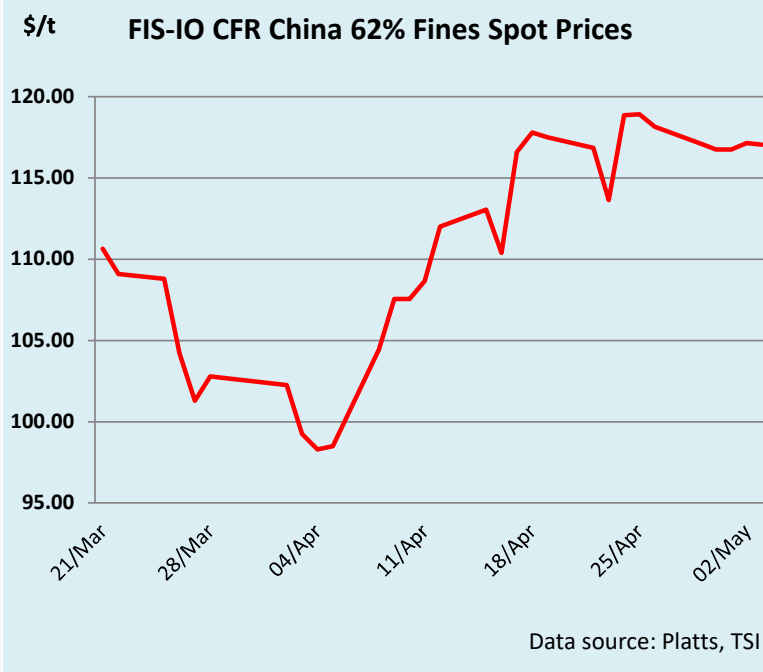

Market Commentary / Recent Trades

On the last day of the Chinese Labour Day holidays, iron Jun future traded within the range of high of \$117.95 and lows of \$116.50.

We observed decent-sized trades on Q3 outright today, totaling 30kt. Later in the day, we also 15kt traded on Q4 outright. On the spreads, May/June narrowed by 5 cents from \$0.40 to trade at \$0.35 in decent size this evening.

The DCE will reopen on Monday morning.

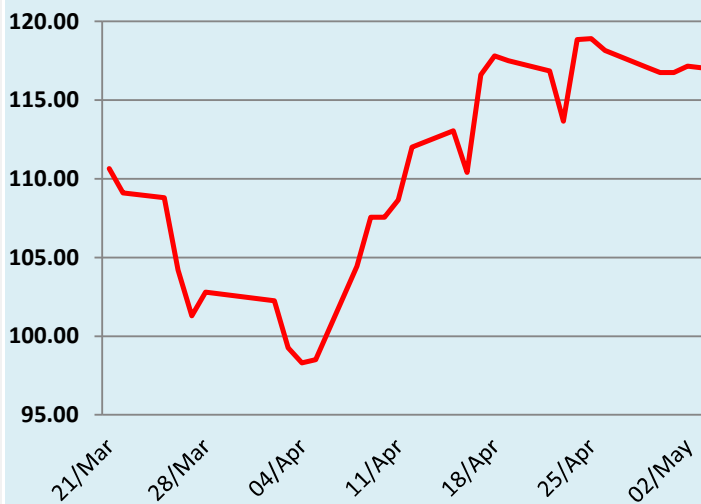
市场评论 / 近期交易
