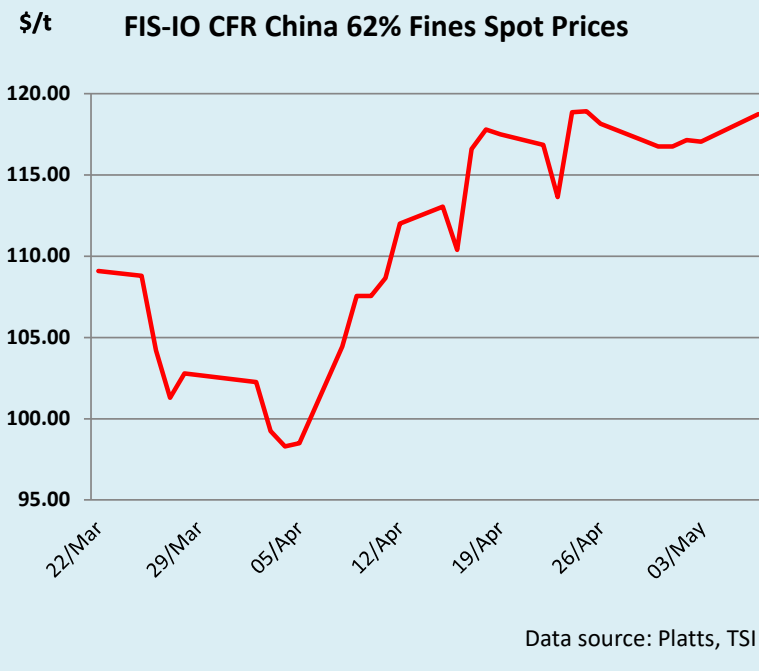

## Market Commentary / Recent Trades

This morning, iron ore Jun opened at \$119.40, reaching highs of \$119.45 early on before declining to lows of \$118.05 in the latter half of the session, and closing at \$118.20. In the afternoon, Jun opened at \$118.35 and quickly rose to highs of \$118.65, but later dropped to lows of \$117.50 in the last half-hour before closing at \$118.10.

May/Jun widened significantly throughout the day. The spread opened in the morning at \$0.15, widening to trade at \$0.25 in large size of over 90kt, before ticking up further to \$0.35 by the end of the session. Notably, Q1-25/Q2-25 also traded at \$2.10 in 10ktm. We saw significant Q4 outright selling interest this morning as well, trading in a total of 46kt. In the afternoon, May/Jun widened further to \$0.40, while Jun/Aug traded at \$1.15 in over 140kt.

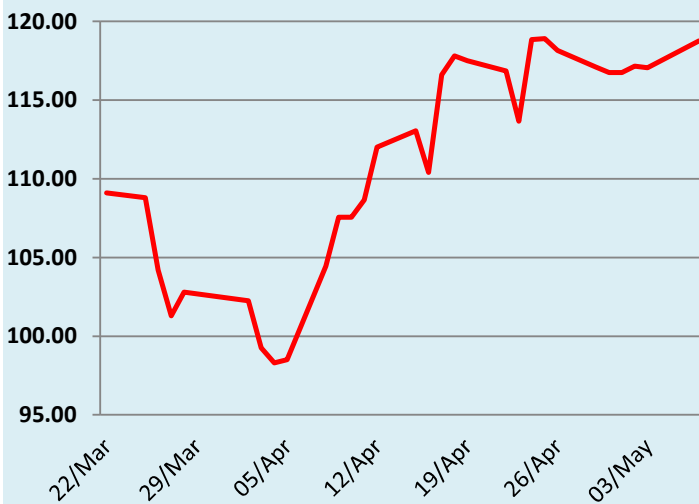

## 市场评论 / 近期交易

今早铁矿石6月以119.40美元开盘，一度上涨至119.45美元的高点，随后下跌至118.05美元的最低点，收于118.20美元。下午6月开盘于118.35美元，迅速上涨至118.65美元的高点，随后在最后半小时下跌至117.50美元的最低点，最终收于118.10美元。

5月/6月全天价差明显扩大。上午开盘时交易于0.15美元，随后扩大至0.25美元，成交9万吨。收盘时进一步扩大至0.35美元。此外，25年Q1/25年Q2在2.10美元交易单月1万吨。今早Q4也有不错的抛售兴趣，总计4.6万吨。下午5月/6月价差扩大至0.40美元，6月/8月在1.15美元交易超过14万吨。
