The Greek Navy resumed drills in an expanse of water just off the country's coast, effectively blocking Russia's ability to use the area for the transfer of petroleum between tankers. Shell Plc's chief executive officer used a trip to Washington to deliver a plea for stability months before a US presidential election that threatens more upheaval in the global energy sector. A sharp rebound in oil flows from both the US Gulf and west Africa drove an increase in global seaborne crude shipments last month. The American Petroleum Institute reported US crude inventories increased by 4.1 million barrels last week, according to people familiar.
