



A sudden and surprising upturn in the world's most important oil price may be set to ease off thanks to an influx of supply from the US. A new integrated refiner in China has been snapping up cargoes of crude, signaling its plant may be nearing an opening after several delays.

Saudi Aramco is poised to take a stake of about 10% in a powertrain joint venture with Renault SA and China's Zhejiang Geely Holding Group Co., according to people familiar with the plan, a smaller commitment than originally signaled by the world's biggest oil company. OIL FIXTURES




