
The London afternoon session opened at \$110 as iron ore continued to show strength to hold near its highest close in a month, price continued to rally and put in highs of \$110.40 before retreating to the session lows of \$109.40 and eventually closing at \$109.80.


The session primarily saw front end outrights trading again, spreads were a little quiet aside from a keen sell on Jul/Sep trading \$0.70 in 40kt, Jul/Aug trading \$0.35 again in 25kt and Sep/Jan trading \$1.85 in 75kt which marked the notable trade of the session.
