


The London afternoon iron ore session opened at \$106.20 and saw some relief from the downtrend throughout the Singapore day, price ticked up suddenly before the start of the session and the momentum carried on printing highs of \$106.95 before closing at \$106.25. The session was very quiet spread wise other than Jul/Aug trading \$1.60 and \$1.65 in 10kt each, however there was notable selling interest in August outrights, trading in 150kt+.


