



The London afternoon session opened today at \$108.20 and immediately sold off to the session lows of \$107, price recovered slightly to \$107.95 before continuing its reversal to close \$107.10. The session remained very quiet spreads wise, August outrights saw good buying interest trading in a number of 5-20kt clips. Cal25 traded \$103-\$103.5 in a total of 5kt, 1H-25 and 2H-25 both traded in 5kt clips alongside Q1 trading in 2kt+ and Q4 in 5kt+.
