


Straight after open we saw a dollar drop to the \$107.60 levels before stabilizing marginally until towards the end of the session we dropped off to daily lows of \$107.00 where we closed.

Prior to the session open we saw the continuation of Aug/Sep trading at \$0.25 in a couple decent clips. However, in session the spread of note was Jul/Sep which traded at \$1.30 with the move in flat price in a total of 110kt.
