


18 July 2024

On the open of the London afternoon session, we saw a drop off to \$104.60 levels before quickly rising to reach \$105.40 the session highs. However, we subsequently dipped to lows of \$104.50 and closed at \$104.65.

The session once again had minimal trades of note. We saw pre-open Aug/Sep trade \$0.20 in 40kt. We then saw Aug/oct trade 45 cents in a total of 25kt. The trade of note was Jul/Sep at \$2.60 in 100kt. We also saw some liquidity further out with Cal 25 trading \$101 in 5kt.
