


The London afternoon session opened today at \$100.80 and saw a quick spike up to the session highs of \$101.15 before selling off to the lows of the day at \$100.10, price closed just above at \$100.20.

The session saw some decent interest on quarterly spreads, Q1/Q2 narrowed again to trade \$1 in a 20kt clip alongside Q4/Q1 which also saw good buying interest to trade 25kt at \$1 and a further 80kt at \$1.05. Cal25 traded in 10kt at \$97.25 alongside Q4 outrights having decent interest to trade in a total of 50kt+ and Aug/Sep traded in a 10kt clip at \$0.2.
