


The London afternoon iron ore session opened at \$102.20 and immediately sold off to the session lows of \$101.70 which also marked the lows of the day, price immediately recovered from the level and went on to print highs of \$102.50 before selling off again to close.

The afternoon saw some interest in quarterly spreads including Q4/Q1 which widened slightly to trade \$1.20 in a total of 15kt, Q1/Q3 traded \$2.35 in a 10kt clip and on the monthlies Aug/Sep traded \$0.2 in 70kt+.
