


London's afternoon iron ore session opened today at \$102.45 and quickly spiked up to the session highs of \$102.65 before tanking to lows of \$101.05 where price spent the second half of the session, the market closed just underneath at \$101.

The session was a relatively quiet one spreads wise, front month outrights primarily traded in multiple clips of 5-30kt. Notably Aug/Sep/Oct fly's traded flat in a total of 40x80x40kt, alongside Nov/Q1 printing again at \$1.25 in 30x10kt.
