



The London afternoon session opened today with August price at \$101.50, price quickly put in the lows at \$101.40 before gaining strength and rapidly climbing to highs of \$103.15. The rally was potentially caused by 1 million tons of short position covering which naturally squeezed the market higher, the session closed at \$103.

The notable trade of the session was Aug/Sep, which once again had continued interest from the Singapore day, to trade at \$0.2 in 400kt+, Q4/Q1 also traded at \$1.15 in 5kt which was a very keen sell. Quarterly outrights such as Q4 saw some decent interest to trade in a total of 25ktm and Aug/Oct traded at \$0.4 in a total of 30kt+ across a couple of clips.
