Another exceptionally hot summer, accompanied by drought, flooding and typhoons, is risking Chinese crop harvests and lifting power demand as climate change creates more extreme weather. Phillips 66 Sweeny and Delek Tyler refineries are within the possible projected path of Tropical Storm Beryl, according to Energy Information Administration and National Hurricane Center data. India's oil demand fell by 3.53% m/m to 19.99 million metric tons in June, according to data released by the Petroleum Planning and Analysis Cell. The number of supertankers headed for China dropped to the lowest in almost two years, adding to recent concerns about demand in the largest oil importer during the second half of the year.




